## ALL x Singapore Airlines 50% Bonus Miles/Points Offer

## **Terms and Conditions**

- 1. This 50% bonus points/miles promotion ("**Promotion**") is organised jointly by Singapore Airlines Limited ("**SIA**") and AAPC Singapore Pte Ltd ("**ACCOR**").
- 2. The Promotion is valid only for KrisFlyer miles converted to ALL Reward points or ALL Reward points converted to KrisFlyer miles from 00:01am (GMT+8) on 9 September 2025 to 23:59pm (GMT+8) on 30 September 2025 ("**Promotional Period**").
- 3. You must be a registered KrisFlyer member **and** ALL member to participate in the Promotion.

## 50% more ALL Reward Points

- 4. During the Promotional Period, KrisFlyer members converting KrisFlyer miles to ALL Reward points will receive a 50% bonus in ALL Reward points accrued on their account as a result of the conversion ("**Bonus Points**"). For example, 4,500 KrisFlyer miles converted will result in 1,500 ALL Reward points being awarded (1,000 ALL Reward points + 500 Bonus Points).
- 5. KrisFlyer miles shall be converted through the members' KrisFlyer account under the following conversion rate: 9 KrisFlyer miles to 2 ALL Reward points + 1 Bonus Point. ## 50% more KrisFlyer Miles

converted will result in 1,500 KrisFlyer miles being awarded (1,000 KrisFlyer miles + 500 Bonus Miles).
